Collective Encounters is seeking a participatory theatre maker or artist (any discipline) to lead an exciting short-term project working with a range of parent and family groups to share experiences and influence services in Liverpool. You will have excellent participatory arts credentials and an innovative and ethical approach to working with communities to co-produce knowledge.

## **The Company**

Collective Encounters' mission is to use creativity and knowledge for social justice and positive social change. Operating since 2004 and based in Liverpool, Collective Encounters delivers a broad range of participatory theatre projects, events, and research initiatives, creating new work that builds power. We are committed to the development of the applied and participatory sector, and we provide a monthly programme of online training

and discussion events through the Centre for Excellence in Participatory Theatre.

## **The Project**

'Families in Action' is a partnership between PSS Parent & Baby service, Sanctuary Family Support, and Collective Encounters. The project will use creative engagement to share experience and promote understanding about different family situations and the different things families might need from services. The main groups to be involved have already been identified and include a parent & baby group, a carers' mutual aid group, and a care-experienced youth group, all of whom have an existing relationship with Collective Encounters.

#### The Role

You will work with a co-production team of professional artists, parents and carers, to design and deliver a series of 9 creative workshops and 3 events intended to gather views from a range of groups about what different families need from services and how they can be made more inclusive. You will co-produce creative outputs (e.g. performance, poetry, artwork) to document and share your findings.

You will work closely with the Co-Artistic Director (Women & Youth) and the Co-Artistic Director (Research) who will support the project planning and reporting, and co-facilitate some of the sessions where appropriate. A Support Artist will support session delivery and resourcing.

## Requirements for successful applicants

- Experience of delivering excellent participatory arts projects
- Experience of managing participatory arts projects and budgets
- Highly creative and collaborative
- Open, inclusive, and trauma-informed in your approach to participatory arts
- Experience of working with family groups and/or personal experience of using parenting, perinatal, family, or related, services
- Strong understanding of creative participatory research and the ethics surrounding it
- Excellent interpersonal skills and the ability to communicate with a range of people
- Recent Enhanced DBS check for work with children and vulnerable adults
